BALLET

This class focuses on the fundamental elements of ballet technique and performance. Dancers will concentrate on body alignment, flexibility, and muscle control.

CREATIVE MOVEMENT

This class is a way for children to explore movement through music while developing basic physical skills. Creative movement allows children to use their imagination and creativity while learning basic ballet technique.

JAZZ

Jazz is a combination of ballet technique mixed with modern dance to create a style that is exciting to watch! Dancers will learn how to isolate their bodies, use the music to complement their moves, and have fun!

Fall Season Info

Session begins September 9.

The dancers will show off what they learned during our show case at the end of the session. Our show case will be on the last day of class, December 16th. Parents will be able to take videos and pictures at that time. Please refrain from taking video and pictures during class as it distracts the dancers while in class.

New Procedures

We have adopted these new procedures to ensure your child's safety:

- No hands on assist
- No class will have more than six students without informing other parents in the class
- Breaks between classes for instructor to disinfect the studio
- Only water in sealed water bottle allowed in the studio
- Parents will not be allowed in the studio
- Parents will not be allowed to take pictures from the door of the dance class
 - Have your dancer use the bathroom before class to keep the flow of the class
 - Do not stand by the studio door to keep distractions to a minimal
