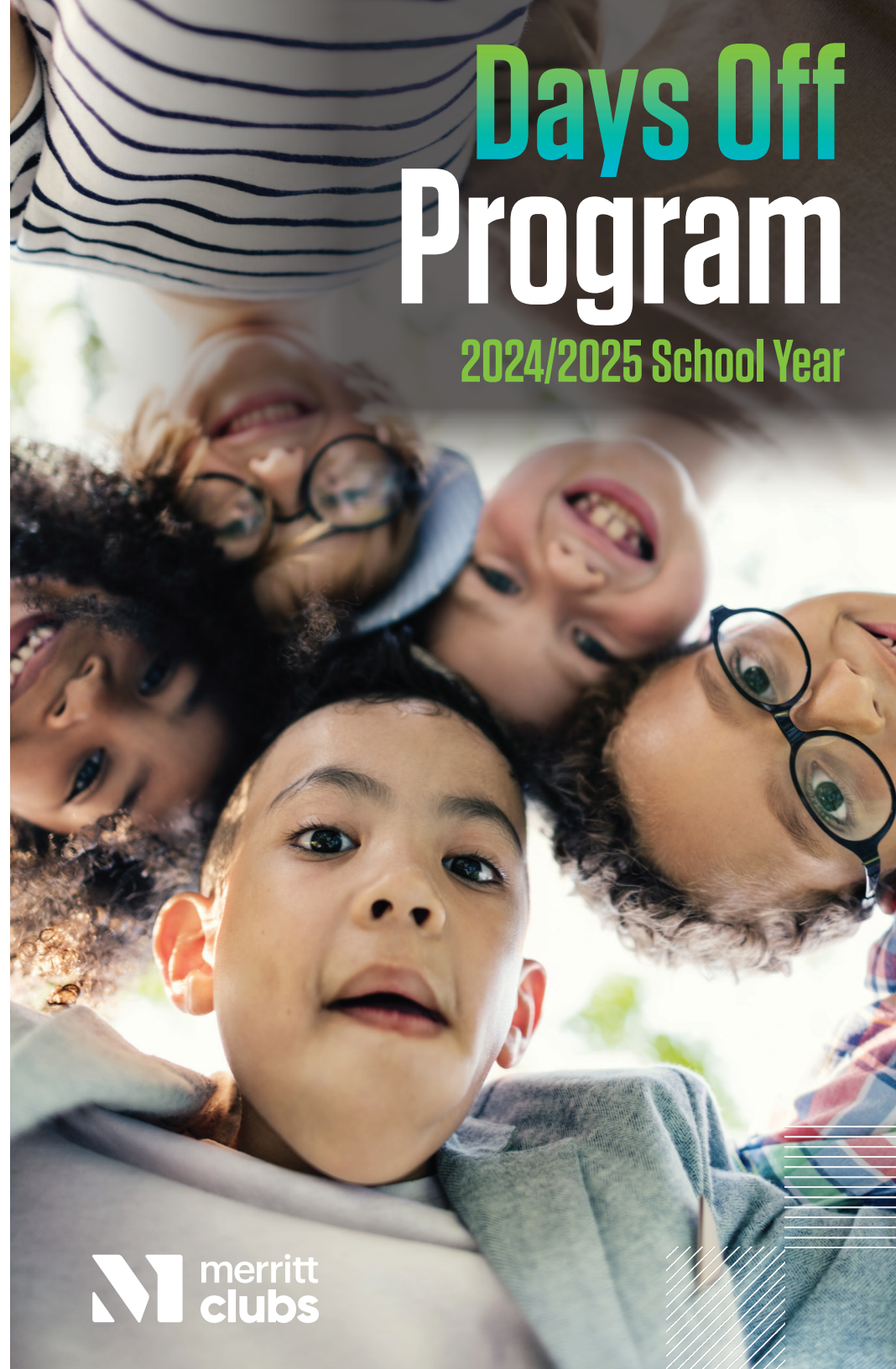

Policies and Procedures

- NO ELECTRONIC DEVICES ARE ALLOWED AT MERRITT DAYS OFF PROGRAMS. This includes but is not limited to cell phones, video games, tablets, etc.
- Merritt reserves the right to offer an age-appropriate movie or show if needed for inclement weather or other unforeseen circumstances when the regularly planned activities are not able to be completed. (Games and crafts leading up to and/or following a movie/show will be within the same theme.)

All Days Off Program days are full days (8:00am – 6:00pm) and will include activities such as sports youth challenges, relays, games, crafts, dancing, swimming and so much more!
