# Class Descriptions

### **BALLET/TAP**

Class focuses on the fundamental elements of ballet technique and performance. Dancers will concentrate on body alignment, flexibility, and muscle control. In their tap portion of class dancers will learn how to use their feet to make different rhythms and sounds.

### **CREATIVE MOVEMENT**

This class is a way for children is explore movement through music while developing basic physical skills. Creative movement lets children be use their imagination and creativity while learning basic ballet technique.

#### **JAZZ**

Jazz dance a high-energy dance style that has a liveliness that sets it apart from traditional dance forms, such as classical ballet. Like jazz music, jazz dance features improvisation.

#### **HIP HOP**

Dancers will learn various hip-hop styles and body awareness to age appropriate music. Dancers will gain self-confidence, learn hip hop dances from the past all the way to todays' popular dances, and have fun!
